### **Perspective District Development Plan for Aurangabad District (PDDP)**

Collector, Aurangabad District invites Expression of Interest ( EoI ) from Organizations of National / International repute to prepare Perspective District Development Plan ( PDDP ) for Aurangabad District of Maharashtra. The PDDP would enlist development goals and objectives, programs and projects to achieve the objectives, strategy for implementing the programs and projects and a mechanism to review strategy so adopted in all spheres of social and economic activity. It should address the issue of poverty as an integral and a priority component in all decision making, whether related to economy, environment, governance or delivery of public services, The PDDP would strive to achieve social, financial equity in development while creating a robust economy for the district. It would focus on issues such as, liveability, sustainability, competitiveness, bankability, good governance and quality of life in the district. It would be a reflection of the stakeholders' preferred future of the district

In brief, the following activities would describe the development of the Perspective District Development plan (PDDP)

1. Documentation of past and current development initiatives in the district
2. Analysis of the District stakeholders and their roles
3. Preparation of background papers in the area of economy, environment, governance, poverty and other related issues.
4. Identification of issues, focus areas and strategy through district wideconsultation with stakeholders.
5. To develop strategic vision for the district for the next ten years.
6. To develop a Comprehensive Perspective District Development Plan (PDDP) keeping into account the five points as enumerated above.

The Preparation of the PDDP would have to be done by taking into account the inputs from all stakeholders through a district wide consultation and developing a strategic action plan for its implementation.it should list out prioritization of sectors/focus areas through the consultative process and identification of short, medium and long term goals. It would also include development of District Financial Assistance Program (DFAP) and identification of

implementation arrangements from amongst the stakeholders. It would provide a strategy for encouraging local business growth, strategy for securing finance for new business, promoting foreign direct and domestic inward investment and strategy for upgrading basic infrastructure across various sectors to meet future demands. It would also cover issues of crime prevention, reorganisational strategies. Rehabilitation issues and development of social infrastructure would be a major component . It would also include issues relating to ensuring accountability, transparency in governance.

The organisations would be required to document the PDDP experience by preparation of final report consolidating the process, findings and recommendation arising out of the PDDP

Organisations willing to participate in expression of interest (EoI) should apply to the address given below on or before 26<sup>th</sup> July 2010 by 3.00 PM. All EoIs received in time will be scrutinised according to the eligibility criteria and the eligible EoIs would be shortlisted and will be invited for a pre bid meeting on a suitable date which will be conveyed to all the shortlisted organisations. Shortlisted organisations would be required to submit their price bids according to the tender documents finalised by Collector office Aurangabad after the pre bid meeting. Therefore, no financial offers are required to be submitted with the EoI at this stage. Only organisations, who have prepared similar perspective development plans for atleast one district or one million plus city in India will be considered for this work. EoIs complete with all documents should be submitted in sealed envelopes and top of the envelopes it should be clearly marked as "PERSPECTIVE DISTRICT DEVELOPMENT PLAN :AURANGABAD DISTRICT" and NAME OF AGENCY.
